Sir/Madam,

This has reference to your online application bearing registration no EX-02680-1718 on the above subject.

In this regard, the following deficiencies / requirements have been observed during the scrutiny of your application.

1. The school is required to establish mathematics lab & intimate the size with supportive evidences i.e. Photographic and Documentary.
2. 03 teachers are short. Therefore, the school is required to appoint more teachers (on permanent basis instead of adhoc) who are trained and qualified as per provisions of Affiliation Bye-Laws of the Board to maintain section teacher ratio i.e. 1.5 teachers per section at each level. Hence, a copy of revised staff statement is required to be submitted showing Name, Qualification, Designation, Date of Appointment, Date of Confirmation, classes assigned, experience etc.
3. The school is required to submit a certificate/proof (of salary) issued/certified from the Competent Authority/Education Department of the State i.e. DEO, to the effect that the school is paying salaries and other allowances to its staff as per State/Central Govt. norms along-with latest copy of acquaintance-roll with complete details of all staff i.e. name, designation, pay-scale, salary details etc.
4. The school is required to submit a certificate from the Bank i.e. Branch Manager through which the salaries of all staff are disbursed to the effect that the disbursement of salary of all staff through ECS mode.

However, in view, the academic interest of the students, I am directed to convey approval of the competent authority for provisional extension of affiliation upto 31.03.2019 alongwith permission for registration of bonafide candidates of class IX / XI and submission of list of existing candidates of the School for class X and XII for current session.

However regularization of affiliation from 01.04.2017 for a period of 05 years will be subject to the outcome of Inspection Report to be submitted by the Inspection Committee after inspection of the School and submission of compliance/documents in case of deficiencies observed on examination of Inspection report.
